

# Purpose Camp 2024

The Purpose (**Camp**) is an overnight camp to be attended by children in Years 9 to 12 at school (**Child**) organised by the Sydney Catholic Youth agency of the Catholic Archdiocese of Sydney (**Archdiocese**).

The Camp is an opportunity for teenagers to understand their faith and relationship with God and how they can live their faith in their daily lives. In 2024, the Camp will be held from 9:30am on 22 April 2024 to 1:00pm on 24 April 2024 at the Benedict XVI Retreat Centre, 347 Grose Wold Road, Grose Vale NSW 2753.

In order to participate in the Camp, each Child's parent/guardian must agree to the Camp Terms and Conditions (**Camp Terms**) as set out below, complete the form, sign and return it to <u>info@sydneycatholicyouth.org</u>.

## Camp Terms

## General

- 1. I, the undersigned, agree for my Child to participate in the Camp.
- 2. I understand that the activities that my Child may participate in during the Camp may include, but are not limited to, indoor and outdoor group activities, basic accommodation, communal eating, socialising, travelling in chartered buses, and that risks may arise during these activities.
- 3. I understand that during the Camp activities may involve physical demands and it is my responsibility to notify the Archdiocese if my Child may not participate in any particular activity.
- 4. I indemnify and release the Archdiocese, its officers, employees, volunteers and agents against claims and losses of any kind arising out of or in connection with my Child's participation in the Camp.

#### Rules

- 5. I agree and will undertake to ensure that my Child abides by laws applicable to the Camp, the Camp Terms, all instructions given by group leaders and any rules notified to me by the Archdiocese (collectively, **Rules**) from time-to-time.
- 6. I understand that a breach of the Rules may result in the removal of my Child from the Camp.
- 7. If my Child is removed from the Camp, I accept responsibility for all costs incurred, including any travel costs associated with my Child's departure from the Camp.

## **Payment and Cancellation**

- 8. The registration fee is \$250 (including GST). Early bird registrations completed before 25 March 2024 is \$230 (including GST). The registration fee includes shared cabin accommodation, food, transport and activities.
- 9. Registration and payment is made through the Trybooking website at *https://www.trybooking.com/CHNZE*. There is an additional fee of \$0.50 per registration for booking via Trybooking.
- 10. Registrations close on 15 April 2024.
- 11. Payment of the total registration fee is required at registration.

- 12. If I cancel before 15 April 2024, I am entitled to receive a refund of the total registration fee. The \$0.50 per registration Trybooking fee is not refundable. I am not entitled to a refund for a cancellation made after 15 April 2024, or in circumstances where my Child does not attend the Camp.
- 13. If for any reason the Camp cannot be commenced or is not capable of continuing as planned in any respect, the Archdiocese reserves the right to cancel the Camp or amend the Camp program at its discretion at any time.

## **Medication or Special Needs**

- 14. Prior to the Camp, I will notify the Archdiocese if my Child has any special needs, disabilities, allergies or other medical condition or medication requirements.
- 15. I understand that every effort will be made by the Archdiocese to communicate with me in the event that my Child suffers any illness or accident.
- 16. I authorise the Archdiocese to provide consent on my behalf where it is impracticable to communicate with me for my Child to receive emergency medical treatment as may be deemed necessary at any time during the Camp.

#### Filming and photographing

- 17. I acknowledge that my Child may be filmed and/or photographed (**Footage**) when attending the Camp.
- 18. I agree to and permit the Archdiocese and its nominees using the Footage and my Child's, image, likeness and voice in accordance with this consent.
- 19. I consent to the Archdiocese and its nominees, without limitation, using, reproducing, exhibiting, editing, adapting, compiling with other works or materials, transmitting, broadcasting, publishing and distributing the Footage in any media at its discretion, for educational, promotional, marketing and other purposes (including commercial purposes) associated with the Camp, or the Archdiocese's events, or consistent with the Archdiocese's (and broader Catholic community's) activities and objectives.
- 20. I acknowledge that the Archdiocese is not obliged to publish or otherwise use the Footage or any part of it.
- 21. I agree that any form of intellectual property rights in the Footage and all works derived or created under it are owned by the Trustees of the Roman Catholic Church for the Archdiocese of Sydney on behalf of the Archdiocese, and any intellectual property rights that my Child may have in the Footage are fully assigned to the Trustees of the Roman Catholic Church for the Archdiocese of Sydney on behalf of the Archdiocese.
- 22. To the full extent permitted by law, I consent to the doing of anything in relation to the Footage that (but for the consents provided in this Terms and Conditions document) would otherwise infringe any moral rights or similar non-assignable personal rights that my Child might otherwise have including but not limited to publishing the Footage without attribution and modifying/ adapting the Footage.

#### Privacy

- 23. I acknowledge that the Archdiocese and its nominees collect my Child's personal information for purposes of organising and delivering the Camp, including engaging with my Child regarding the Camp, assisting my Child during the Camp, and promoting the Camp. The Archdiocese may disclose my Child's personal information to its related entities, contractors and third party service providers for purposes relating to the Camp.
- 24. I acknowledge that the Archdiocese may collect sensitive medical information about my Child and will only use my Child's medical information for the purpose of assisting my Child in the event that my Child becomes unwell or need medical assistance during the Camp.
- 25. The Archdiocese's privacy policy available at https://www.sydneycatholic.org/terms-and conditions/#privacy provides information about how to access and seek correction of

personal information, how to complain about a breach of Australian privacy laws, and how complaints are dealt with.

26. I agree that the laws of New South Wales, Australia govern these Camp Terms.
